

AACO PRIVACY NOTICE FOR SUPPLIERS

Last Updated: January 15, 2026

At Aramco Americas Company (“AACO” or “we”), your privacy is important to us. We have prepared this Privacy Notice to provide suppliers and potential suppliers (collectively, “you”) with information about our privacy practices. This Privacy Notice applies when you access AACO supplier websites or online services that link to or refer to this Notice (each, a “Supplier Site”) or otherwise provide AACO your personal information. Please read this Privacy Notice to fully understand what personal information we collect, how we collect and use that personal information, and how we protect personal information.

As used in this Privacy Notice, “**personal information**” means information that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, to you. Personal information does not include publicly available, deidentified, or aggregated information.

1. What Personal Information We Collect

We may collect personal information about you, along with information about your business or company. The personal information we collect may include:

- *Identifiers and Personal Records*, such as your name, signature, postal address, IP address, email address, phone number, login credentials, financial information, and other similar information.
- *Commercial Information*, including records of products or services obtained or considered.
- *Internet or Other Electronic Network Activity Information*, including information about your use of the Supplier Sites, such as your IP address, browsing history, search history, and other information regarding your interactions with the Supplier Sites.
- *Geolocation Data*, including approximate location derived from your device IP address.
- *Audiovisual Information*, including images, photographs, and video of you, and audio recordings, such as if you participate in phone calls on a recorded line or interact with us by videoconferencing.
- *Professional or Employment-Related Information*, including your job title, employer, license information, resumes, and references.
- *Inferences* derived from other personal information we collect reflecting preferences, characteristics, psychological trends, predispositions, behavior, attitudes, intelligence, abilities, and aptitudes.

We may also collect personal information that does not fit into the categories above, for example the contents of communications you choose to share with us.

As permitted by law, we may also receive information about you from publicly and commercially available sources, such as public business records and government records. We may combine this information with other information we receive from or about you, for example, to verify the truthfulness of information that you have provided. Your personal information may be converted into deidentified, anonymized, or aggregated data. Once information is deidentified, we will not attempt to reidentify it, except as permitted by law.

2. Sources of Personal Information

We collect the categories of personal information described above from the following categories of sources:

- *Directly from you*, including when you fill out a form, communicate with us, or otherwise interact with us.
- *Automatically*, including through cookies and tracking technologies when you use the Supplier Sites.
- *From vendors that help us run our business*, including payment processors, information technology vendors, and other service providers.
- *From other sources*, including your employer, professional organizations, and other parties that may provide us with information related to you.

3. How We Process Your Personal Information

We process and use the personal information identified above to help us decide whether to buy goods or services from you, to communicate with you, to fulfill our obligations to you, to operate our business, and to comply with applicable laws and regulations. For example, we process and use personal information:

- For business execution and administrative purposes, such as evaluating and screening potential suppliers, registering you or your business, managing our relationship with you and your employer, and performing our contractual obligations to you (e.g., processing payments);
- For organization and management of our business, such as operating, analyzing, and improving our supplier relationships, business processes, and information technology systems, analyzing use of and improving the Supplier Sites, and monitoring and preventing fraud and information security threats;
- To communicate with you and your employer;



- For business reorganization, such as preparing for or entering into a merger, sale, purchase, joint venture, assignment, transfer, or other disposition of our business, assets, or stock, or rehabilitation, capital venture, or any similar transaction;
- For security and integrity, such as managing access, maintaining systems and servers, enhancing information technology, maintaining the security of our operations and systems, protecting our premises, assets, systems, and intellectual property; and
- For legal and/or regulatory compliance including litigation and defense of claims.

We also may use your personal information as we believe is necessary or appropriate to protect, enforce, or defend the legal rights, privacy, safety, or property of AACO and its affiliated companies, the Supplier Sites, our employees or agents, or other users and as otherwise required or permitted by law.

4. How We Disclose Personal Information

We may disclose your personal information to the following parties for the purposes set forth above:

- *Our affiliates*, including Saudi Aramco and other Aramco Group affiliates and entities.
- *Service providers* that we use to support our business (e.g., hosting, cloud storage, and other services).
- *Public authorities* as required by law, when responding to government requests, or in connection with corporate transactions.
- *Parties to corporate transactions* as part of a corporate transaction or proceeding such as a merger, financing, acquisition, bankruptcy, dissolution, or a transfer, divestiture, or sale of all or a portion of our business or assets.
- *Other recipients* as necessary to facilitate your provision of services to us, to facilitate services we may provide to you, or otherwise upon your request.

5. How Long We Retain Personal Information

We maintain the categories of personal information described above for as long as necessary for the purposes described in this Privacy Notice or otherwise authorized or permitted by applicable laws or regulations, including where retention of your personal information is reasonably necessary to: manage your relationship with us, carry out our operations, or satisfy another purpose for which we collected the personal information; carry out a disclosed purpose that is reasonably compatible with the context in which the personal information was collected; comply with our legal or regulatory obligations; or protect or defend our rights or property.

Where personal information is used for more than one purpose, we will retain it until the purpose with the latest period expires. For more information about our retention policies, please contact us as provided below.

6. Online Tracking

We and our vendors that provide content or functionality on the Supplier Sites may use cookies and similar tracking technologies that collect information when you interact with the Supplier Sites. Depending on your device and browser settings, these technologies may collect information such as your IP address, device identifiers, user preferences, approximate geolocation, the pages you click on, and the website you visited immediately beforehand. Additionally, these technologies may collect details about how you interact with the Supplier Sites. We may use these technologies for various purposes, including to facilitate administration and navigation on the Supplier Sites, to better understand and improve the Supplier Sites, to tailor our advertisements to you, and to provide you with a customized online experience.

Technologies we use may include but are not limited to:

Cookies. Cookies are small files that are set by your browser on your computer or device when you visit a website. Cookies may be used to store a unique identification number tied to your computer or device so that you can be recognized as the same user across one or more browsing sessions, and across one or more sites.

Most web browsers are set to accept cookies by default. Depending on your browser or device, you may have settings that allow you to control how cookies are handled, including whether browser cookies are set and to delete them. For example, you may be able to configure your browser to block cookies or to notify you when a cookie is being set. For more information about whether these settings are available, what they do, and how they work, visit your browser help material. Please be aware that some features of the services may not function properly or may be slower if you disable cookies.

Web Beacons and Other Tracking Technologies. We, along with our vendors, also may use technologies called beacons (or “pixels”) that communicate information from your device to a server. Beacons can be embedded in online content, videos, and emails, and can allow a server to read and collect certain types of information from your device, know when you have viewed particular content or a particular email message, determine the time and date on which you loaded the web beacon, and the IP address of your device. We and our vendors may use web beacons, including the Meta Pixel, for a variety of purposes, including to analyze the use of our services and to target and deliver ads.



Certain advertising tracking technology vendors may participate in the Digital Advertising Alliance ("DAA") AdChoices Program and may display an Advertising Option Icon for Interest-based Ads that links to an opt-out tool which allows you to exercise certain choices regarding targeting. Please be aware that, even if you are able to opt out of certain kinds of interest-based ads, you may continue to receive non-targeted ads.

You may be able to adjust your browser settings to remove or reject cookies. Some browsers may have a "Do Not Track" setting. Please note that the Websites are not designed to respond to "Do Not Track" settings.

7. Third-Party Content and Links

Some of the content and functionality on the Supplier Sites may be provided by third parties that are not affiliated with us. In addition, the Supplier Sites may link to third-party websites and services that are outside of our control. These third parties may use your information to improve their own services and be consistent with their own privacy policies. We are not responsible for the content or privacy practices of any linked websites that we do not control. This Privacy Notice does not apply to online services that we do not control or maintain.

8. How We Protect Your Personal Information

We strive to maintain adequate technical and organizational measures to protect personal information we process about you, which we provide at no cost to you. However, please note that no data transmission over the internet can be guaranteed to be completely secure. As a result, although we strive to protect your personal information and privacy, we cannot guarantee or warrant the security of your personal information and cannot be responsible for the theft, destruction, or inadvertent disclosure of your personal information.

9. International Data Transfers

Please be aware that information you provide to us or that we obtain as a result of your use of a Supplier Site may be collected in your country and subsequently transferred to the United States, the Kingdom of Saudi Arabia, or to other countries in accordance with applicable law. The laws on processing such information in these locations may be less stringent than in your country and information may be subject to lawful access by U.S. courts, law enforcement, and governmental authorities. By using a Supplier Site, you consent to the collection, international transfer, storage, and processing of your information.



10. Your Rights

You may have certain rights as a data subject under local law. For example, you may have the right to access or delete personal information, as well as other rights.¹ The Supplier Sites may provide you with direct access to view, update, correct, and/or delete your data. 11. Changes to this Privacy Notice

We may modify this Privacy Notice from time to time. Any changes to the Privacy Notice will become effective when the updated Notice is posted on the Supplier Sites. We recommend that you revisit this Privacy Notice periodically to ensure that you are aware of our current privacy practices. Your continued use of a Supplier Site following the posting of changes will mean that you acknowledge our practices as described in the updated Privacy Notice.
